- 1 full payment, due at registration
- **3 Equal payments,** 1st due at registration, 2nd due December 1, 2025, and 3rd payment due March 1st, 2026
- 9 Equal payments, 1st and last payment due at time of registration, remainder payments due October 1, 2025 to April 1, 2026

Payment Information

Fees are due at registration and will include a \$30.00/family non-refundable registration fee. Your full tuition fee, 1st of 3 payments or your first month and last month's tuition for all registered disciplines are due at the time of registration.

Submitting your credit card information authorizes Dancesations Dance Academy to automatically charge your card the registration fee, costume deposits, costume balances (tights etc) and tuition. Fees will be withdrawn the first of each month October 1st, 2025, to May 1st, 2026, unless otherwise stated.

I understand that I must notify Dancesations Dance Academy 7 days prior to the first of the month if I decide to use another payment option. If I do not, I will be charged via credit card for that month.

We do accept cheques, cash, or E Transfer with cc on file. Please note payment must be made by the 1st of each month to avoid the **Late Payment charge of \$25.00 charged on the 2nd of each month**. If payment has not been received within 30 days a dancer may be removed from their classes.

Please be aware that tuition is based on a 9-month dance year (September through May) Monthly tuition fees remain the same regardless of weeks in the month, school vacations, closings, or the number of absences in the month. All fees are non-refundable. If closure is forced upon us all class will continue via Zoom and all payments are still required at full rate.

If your child decides to not return to class, you are still responsible for the remainder of the fees. Withdrawal allowance: If within the first 2 months of registering you wish to pull your dancer a \$25.00/child administration fee will be charged to void your contract with Dancesations. Otherwise, all payments are due at the time of removal at full value rate. No refunds are given after November 1, 2025.

Costume deposits: Each dancer is required to purchase a costume for each routine/discipline for the end year recital.

Costume fees can be divided into 2 equal payments, first due by November 1st, 2025, with the remainder balance due in February 2026 or full payment due November 1st, 2025. This is due by November 1st. For competition costume deposits please enquire.

There are NO refunds for costumes after this date, no exceptions. Any dancer quitting before the end of the term will NOT receive a refund and will forgo their costume.

Studio will close for the following days: All Statutory Holidays, Christmas Break, Family Day, March Break, Easter Monday & 1 Weekend for our competitive teams away competition. (Follow school closures)

Dancesations reserves the right to change or cancel any classes within the weekly schedule. Refunds will only be given if the new day is not acceptable, NOT for changed instructors, class time change within 15 minutes and classes taken will be deducted. Please keep our studio clean. **Dancesations** cannot be held responsible for any lost or stolen items.

Please be advised that, **Dancesations** cannot be held responsible for any personal medical or personal injury that may occur at the studio. The student and their family hereby waive and releases any and all claims that he/she has against the studio, its employees or agents for medical & injury sustained.

The undersigned understands there is a certain element of danger in dancing activities and sports and acknowledges that it has been explained to her/him that caution and care reduce the element of danger and injury. The undersigned also understands, and agrees that **Dancesations** reserves the right, at any time, to void this approval to proceed with normal routine exercise applicable to the

dance arts. I hereby grant permission for my child to participate in all Dancesations program activities including photographs,
recordings, and public performances and allow the location where a program is held. I hereby give permission to have staff arrange
for any emergency medical care including transportation if necessary.

Dancesations should not be treated as a babysitting service; parents are to pick-up their children immediately following their child's last class of the day. We are NOT a day care service; we also are not responsible for taking children to the washroom. Please be available if your child needs help with this.
